# Fido's Playground Doggie Daycare

## Client Release and Agreement

Fido's Playground will exercise due diligence and reasonable care of all animals on Fido's property; and keep the premises sanitary, properly maintained and enclosed. For this, all dogs are handled and cared for by staff without liability on Fido's part for loss or damage from disease, theft, fire, death, escape, injury or harm to any person(s), other dog(s) or its property by said dog; from unavoidable causes, due diligence and reasonable care being exercised.

Should any dog(s) become ill or in need of medical attention, Fido's Playground reserves the right to administer aid and/or use any available veterinarian. Fido's will inform the owner of any illness or medical need and all expenses incurred by such will be paid by the owner of said dog in addition to any other applicable fees.

Each dog entering Fido's Playground must have a minimum of two sets of vaccinations and be spayed and/or neutered after the age of 7 months. Valid proof of vaccinations and spay/neutering certificate must be presented before said dog(s) first day of dog daycare. Owner agrees to maintain vaccinations and present Fido's with up to date records. Dogs arriving with fleas and/or ticks will not be accepted until properly treated. Sick and/or injured dogs will not be accepted unless previous arrangements have been made. Fido's reserves the right to refuse any dog.

Pinch collars, choke chains and shock equipment are not permitted on the premises.

Owner agrees to pay the rate of services in effect on the date a dog is checked into Fido's Playground. Prices are subject to change without notice. Late pick up fees will be applied at Fido's discretion for pick up after 6:00pm.

Owner agrees that said dog(s) will be picked up by the owner or other pre-approved person by 6:00pm Monday to Friday, unless prior agreement was arranged with Fido's Playground. Should said dog(s) not be picked up at the specified time, Fido's is authorized to take whatever necessary actions for the continued care of said dog(s). Owner is responsible for paying all costs and/or charges thereof.

Owner shall remain liable for all costs incurred in the care and maintenance of said dog(s) listed in this agreement. The owner further agrees to be solely responsible for any and all acts of behavior of said dogs(s) while in the care of Fido's Playground. Furthermore, the owner of said dog(s) agrees to pay any and all attorney fees incurred by Fido's Playground if collections of daycare services, training fee and/or other charges are accrued by the owner of said dog(s).

There is a strict NO REFUND POLICY of payments received for services rendered by Fido's Playground.

### ASSUMPTION OF RISK

Dogs are animals and as such can be very unpredictable and have the potential to display unwanted behavior without warning. Working with dogs is not without risk to other dogs, staff, owners, students, family members, guests or possessions. The undersigned hereby agrees to indemnity, agreeing to hold harmless and to release from liability: Fido's Playground, it's principles along with all other related names and combination of names, employees and/or agents for any/all risks associated with any/all products, services of the facility and any/all direct or indirect results thereafter.

### INDEMNITY

The undersigned hereby agrees to indemnity, agreeing to hold harmless and to release from liability: for any claim by any company or persons against Fido's Playground, it's principles along with all other related names and combination of names, employees and/or agents; including legal costs to defend such claim whether or not the damages are caused in whole or in part by negligence, actions or inactions by any of these parties.

RELEASE FROM LIABILITY

I will abide by the rules and regulations of Fido's Playground provided to me and/or posted from time to time on Fido's premises. I certify that my dog(s) have not shown any aggression or threatening behavior towards any persons, other dogs, toys or food.
